TOURNAMENT RULES

Rule 1 - Eligibility

Only members of the Cedar Rapids USBC BA age 18 and older may bowl in the

No bowler may enter or participate more than once in the individual or 2-person event (PER DIVISON). Entry in both events is required when entering either

Entry in the Team Event will be governed by the following conditions:

- A) Not more than three (3) players can compete together more than once in the 5-nerson team event.
- A bowler competing in more than one 5-person team event shall have their first (1st) score count for their all-events score if so entered.
- C) Bowlers entering multiple team events may only participate on/with one team per shift.

Rule 2 - Entry Closing Date

The closing date for entries in the tournament shall be the third Saturday in December. All entries are to be delivered or mailed to the Tournament Director and shall be on the official tournament entry forms only. The postmark on the envelope must show receipt at the post office not later than the first business day following the closing date. Entries received that are not in accordance with the above stated rules will be at the Tournament Director's discretion.

Rule 3 - Averages

Bowlers will use highest previous season average as bowled in a CRUSBC BA sanctioned league, based on a minimum of 21 games. **USBC rule 319a3 shall**

Bowlers not having a previous season average shall use the highest An appeal or protest regarding the decision of the foul judge, scorer, tournament CBUSBC sanctioned average based upon a minimum of 12 games as of December 20, 2025. Summer league averages from CRUSBC sanctioned leagues will be used if bowler has no winter average. All others will bowl scratch with scratch at 230. Previous prize winnings need not be reported. The 10-pin over average rule will not apply.

Rule 4 - Divisions

Division I: Scratch - Average 210 and Above

Singles & All Events- 210 Average and Over, Doubles - 419 Average and Over Team • 1046 Average and Over

Division I I: Average 181-209, Handicap 90% from 230 Singles & All Events - 180 - 209 Average, Doubles

361-418, Team • 901-1045 Average.

Division III: Average 179 and below, Handicap 90% from 230

Singles & All Events - 179 and below Average, Doubles - 360 and below Avg Team • 900 and below Average

All bowlers must bowl in their respective divisions.

Substitutions in lineup must be made not later than 30 minutes prior to the scheduled time to bowl. The substitute will bowl in the position occupied by the person they are bowling for (no bowling order change), NO EXCEPTIONS.

Rule 6 - Order of Bowling and Late Arrivals

The Order of Bowling shall be as submitted on the entry blank. Each shift will start as scheduled or as soon after as conditions permit. Any team or player arriving late shall begin play with the score to count from the frame being bowled and the team or player being ready to bowl in their proper order or turn. In the minor events, the 2-person event will be bowled first with the individual event to follow immediately.

Rule 7 - Practice Balls

Each contestant will be allowed 10 minutes of practice on each pair of lanes prior to the start of the Team and 7 minutes of practice prior to the start of the 2-person event only, but not prior to the individual event in the case of late arrivals.

Each contestant will bowl the three games of each event on the same pair of lanes. The first game of the series will start on the lane on which the team or individual is scheduled. Succeeding games will be started on the lane which the team or individual finished the preceding game. There will be 3 pair of bowlers per set in the Singles/

Rule 9 - Prizes and Awards

Trophies and cash will be awarded. Cash prizes for each event will be awarded per USBC rule 309. A sponsor trophy will be awarded in the team event, if applicable.

Rule 10 - Appeal or Protest

official or board of directors may be made to the USBC. The decision will be rendered by USBC as soon as possible after submission; however, the Tournament Director must have been notified of such an appeal or protest in writing by the individual or team filing the appeal or protest. Such an appeal or protest shall in all cases be made in writing and be signed by the party(s) making the appeal or protest before prizes are awarded. The grounds of the appeal or protest must be stated and under what rule violation it took place. The decision of USBC shall be the final and binding ruling governing the appeal or protest. All protests must be filed within 48 hours of your
